Ontario Extends Emergency Declaration

- The [Government of Ontario](#) is extending the March 17 Declaration of Emergency under the *Emergency Management and Civil Protection Act*, until **June 2, 2020**.
- The declaration will allow Ontario to continue to enforce [emergency orders](#), that are currently in effect until **May 19, 2020**. Please be aware that there is always the potential

for the Government of Ontario to extend the emergency orders past May 19, 2020 if deemed necessary.

 - [Closure of public places and establishments](#) (including recreational centres, libraries, private schools, childcare centres, bars and restaurants, theatres, concert venues) with exemption for emergency childcare for health care and frontline essential service workers
 - [Prohibiting events and gatherings of more than five people](#)
 - [Enforcement of emergency orders](#)
 - Work deployment for [health service providers](#) and [long-term care homes](#)
 - [Closure of non-essential workplaces](#)
 - [Streamlining requirements for long-term care homes](#)

Additionally, all publicly funded schools will remain closed until at least **May 31, 2020**.

Effective May 16, the COVID-19 Assessment Centre in Guelph will be reducing weekend and holiday hours. The centre will be open on Saturday, Sunday and holiday Monday from 9 a.m. to 4 p.m.

SHOULD YOU GET TESTED FOR COVID-19?

Please go to an assessment centre if you have at least one of the following symptoms:

- fever
- new onset cough
- difficulty breathing
- chills
- fatigue
- headache
- sore throat
- runny, stuffy or congested nose
- lost sense of smell or taste
- hoarse voice
- difficulty swallowing
- digestive issues (nausea/vomiting, diarrhea, stomach pain) or
- for young children and infants: sluggishness or lack of appetite

Announcements and Changes to Services

- On May 11, the [Prime Minister, Justin Trudeau](#), announced new measures for businesses to keep their workers on the payroll during the COVID-19 outbreak. This includes:
 - Establishing a Large Employer Emergency Financing Facility (LEEFF) to provide bridge financing to Canada's largest employers

- Expanding the Business Credit Availability Program (BCAP) to mid-sized companies with larger financing needs
 - Continuing to provide financing to businesses through Farm Credit Canada, the BDC, and EDC, including through the Canada Account
- On May 11, the [Government of Ontario](#) encouraged school boards to proceed with celebrations of student achievement, subject to health and safety limitations. Stephen Lecce, Minister of Education, advised boards to reschedule events based on input from local Medical Officers of Health.
- On May 9, the [Government of Ontario](#) announced that provincial parks and conservation reserves would be opening for limited day use. The first areas will be opening on May 11, with the remaining areas opening on May 15. Recreational activities will be limited to walking, hiking, biking and birdwatching. Access to all parks and conservation reserves will be free until the end of the month.
- On May 9, the [Government of Ontario](#) unveiled a plan that provides support to licensed child care providers to ensure they remain sustainable and are ready to open when parents return to work. This will include support for fixed operating costs for eligible centres, rapid funding delivery, a straightforward application process for centres that do not currently receive provincial funding, automatic extension of child care licenses set to expire during the emergency period, and support for staffing costs.
- On May 9, the [Government of Ontario](#) approved an emergency order to enable school board employees to be voluntarily re-deployed to congregate settings during the COVID-19 outbreak. Many of these congregate care settings need custodial staff and maintenance workers.
- On May 8, the [Government of Ontario](#) highlighted ongoing preparations for reopening the economy which included:
 - Providing \$241 million to the new Ontario-Canada Emergency Commercial Rent Assistance Program (OCECRA) to deliver relief to small businesses
 - Providing \$10 billion in support for businesses to improve cash flows by providing a five-month penalty and interest-free period to make payments for most provincial taxes
 - Deferring the quarterly municipal remittance of education property tax
 - Allowing employers to defer Workplace Safety and Insurance Board (WSIB) payments for up to six months.
- On May the 8, the [Ministry of Agriculture, Food and Rural Affairs](#) announced 2.25 million in provincially licensed meat processing plants to better protect employees and ensure supply of safe products to consumers during the COVID-19 outbreak. This investment will support purchasing additional personal protective equipment, redesigning workstations, supporting employees who require mandatory isolation, and work-site mobility and transportation.
- On May 8, the [Ministry of Heritage, Sport, Tourism and Culture Industries](#) announced that professional sport training facilities would be permitted to reopen, provided their respective sports leagues have established health and safety protocols in response to COVID-19.
