4.0 MOH Updates

MOH Update(s):

Dr. Mercer provided an update as follows:

• In 2022, Wellington-Dufferin-Guelph Public Health investigated seven hundred fifteen (715) animal bites. In the same year two (2) bats tested positive for rabies.

- As WDGPH is part of a Ministry of Natural Resources & Forestry (MNRF) enhanced surveillance zone, the Agency was also part of a wildlife aerial baiting program which saw 7.5 million vaccine baits delivered to wild animals by air and ground, since 2015. Rabies cases have since decreased by 95%.
- Vaccine baits do not replace regular rabies vaccinations and pet owners are encouraged to contact their veterinarian if concerned about a bite.
- Dr. Mercer provided a brief update regarding avian influenza (H5N1).
- If residents own domestic chickens that are ill, they are encouraged to visit their veterinarian.
- Residents should be aware to not handle any deceased wild birds or let their pets consume dead wild birds.
- The annual flu shot does not protect against the H5N1 strain.

BH.01.APR0523.R11 – Long-Term Care Home/Retirement Home COVID-19 and Influenza Vaccination Rates 2022

Dr. Mercer introduced and K. Alderson reviewed the contents of BOH Report BH.01.APR0523.R11– as follows:

- Vaccines are one of the most effective ways to prevent against serious illness. WDGPH monitors the vaccine coverage in WDG Long-Term Care Homes (LTCH) and Retirement Homes (RH) carefully to promote vaccine uptake as these populations are among the highest at risk.
- Vaccine rates and coverage in LTCH and RH was high and is a tribute to the homes' individual efforts and the WDGPH vaccination campaigns.
- Booster doses of the Covid-19 vaccines are not mandatory in LTCH and RH, however WDGPH will continue to work with these organizations with a focus on maintaining the high uptake experienced in 2022. The Agency will continue its work to improve the rates in areas with lower coverage to ensure residents are equally protected.

BH.01.APR0523.R12 – Oral Health (Healthy Smiles Ontario)

Dr. Mercer introduced and J. Kwansah reviewed the contents of BOH Report BH.01.APR0523.R12 – as follows:

- As April is Oral Health Month, this report will update the Board on public health dental programs.
- Oral health diseases are seen as one of the most common communicable diseases and highly treatable if detected early. The burden of disease is higher in lower income

- residents, youth, and immigrant families. WDGPH appreciates the hardships of these communities and refers these patients for appropriate care.
- As of April 2023, 60% of the children in elementary schools in WDG have been screened and since 2019 there has been a 33% increase of children with urgent dental needs. The Agency continues to encourage eligible families to enroll in the dental program if needed. More information can be found here.

BH.01.APR0523.R13 - Opioid Surveillance Update

- This report provides preliminary estimates from 2022 of the rate of opioid emergency department (ED) visits and mortality.
- The rate of opioid related ED visits decreased from 2021 to 2022 as did opioid related deaths and both remain below the provincial average.
- WDGPH continues to work closely with community partners in the consistent operation of the FAST Overdose Alert Platform and through thoughtful community partnerships, the Agency will continue to support WDG's collective response to the opioid-related harms demonstrated by the data.
