8.0 BOH Report(s)

BH.01.MAR0123.R06 – Smart Cities Project Update

Dr. Mercer introduced and R. Coghlin reviewed the contents of BOH Report BH.01.MAR0123.R06– as follows:

- Funding has been received for this project and the goal of the project continues to be creating a circular food system.
- Since the last update in 2022, Wellington-Dufferin-Guelph Public Health (WDGPH) released its food security and action plan, which included a food access initiative as well as strategic priorities moving forward, informed by past research. A more fulsome update regarding this plan will be provided towards the end of 2023.
- Private and public partnerships are being investigated for ongoing funding as this initiative will see funding end in the near future.

BH.01.MAR0123.R07 – WDGPH Annual Privacy Program Update

Dr. Mercer introduced and R Ochocki reviewed the contents of BOH Report BH.01.MAR0123.R07 – as follows:

- This is an annual report to the Board of Health.
- Privacy Impact Assessment review provided by R. Ochocki and K. Wilson.
- In 2022 the Agency had only five (5) privacy breaches, down from twenty-two (22) in 2021. None of the five (5) incidents were major and no report to the Privacy Commission of Ontario was necessary.
- This is partly due to WDGPH staff refamiliarizing themselves with their regular roles and a reduction of casual staff.
- There were sixteen (16) MFIPPA requests in 2022, which is an identical number to the previous year. The Agency was able to respond to fifteen (15) requests within a 30-day period with only one (1) needing an extension.
- A review of Bill 88 (Employment Standards Act, 2000) was provided and R. Ochocki informs the Board that WDGPH is in compliance with the revised legislation.

BH.01.MAR0123.R08 - WHY Survey Update

Dr. Mercer introduced and L. Dossett reviewed the contents of BOH Report BH.01.MAR0123.R08 – as follows:

- The survey covers students in grades four (4) to twelve (12), parents, and school staff.
- The first cycle of results from this survey were collected in 2019, and most recently in February 2022.
- Mental health challenges were largely reported by students who do not identify as white, or heterosexual. This group reported severe stress about school and having someone appropriate to speak to about their concerns.
- The Health Promotion Team is developing a communications plan to share this information to relevant organizations within the Wellington-Dufferin-Guelph (WDG) community.
- A Board of Health report, looking at the secondary impacts of the post-pandemic world from a WHY standpoint, is forthcoming.

- Mpox, Pertussis and Invasive Group A Streptococcal (iGAS) Disease are all diseases that have been in the media over the past year.

- Depending on the type of disease, the impact of will be different. WDGPH's Infectious Disease (ID) team coordinates with the Vaccine Preventable Diseases (VPD) and Environmental Health (EH) teams to conduct thorough investigations and inspections to efficiently and effectively follow up on each case reported.
