#### MOH Update(s):

Dr. Mercer provided an update as follows:

- The week of May 8<sup>th</sup> to the 14<sup>th</sup> is Nurse's Week. The significance and impact of nurses of Wellington-Dufferin-Guelph Public Health (WDGPH) were recognized by Dr. Mercer.
- May 3, 2023 is Vaping Awareness Day. Dr. Mercer provides an update on vaping in the Wellington-Dufferin-Guelph (WDG) community and advises the Board that a more fulsome report is expected in 2024.
- The community is currently seeing a rise in illegal vaping products being sold in local stores that are not in compliance with public health guidelines. WDGPH employs youth test shoppers and to date it was found that 20% of stores in the WDG area have sold vape products to minors.
- WDGPH has a progressive disciplinary process for vendors who sell illegal vaping products, ranging from monetary fines to loss of license.
- Vaping is on the rise across the province. It is a very concerning issue that poses many serious health risks and current research does not demonstrate that it is the most effective product for smoking cessation.

## <u>BH.01.MAY0323.R14 – Food Safety Program Report: International Women's Day</u> <u>Luncheon Event Enteric Outbreak</u>

Dr. Mercer introduced and P. Medeiros reviewed the contents of BOH Report BH.01.MAY0323.R14 – as follows:

- This report reviewed the enteric outbreak that occurred at the Best Western Plus Orangeville Inn and Suites on March 14, 2023 caused by the bacteria, *Bacillus Cereus*.
- The Agency acted quickly and conducted a thorough investigation and included an outbreak team to identify and secure the suspect food sources to prevent further consumption and illness. Using innovative methods, such as an outbreak questionnaire, the team was able to gather attendee responses more efficiently.
- Mass catering events present unique challenges, and WDGPH and its experienced Public Health Inspectors will continue to evolve the prevention approach to maximize safe food handling practices.
- A board member requests clarification regarding home-based kitchen identification and licensing.
- Any individual who wishes to sell food from their home must notify the Medical Officer of Health and the kitchen is required to be inspected. There is a communications strategy currently being developed to identify those who have not yet notified the Agency.
- Clarification requested regarding food safety for the International Plowing Match in September 2023. WDGPH is working very closely with the organizers of this event and are part of the planning to ensure all vendors are aware of the importance of proper food safety management.

#### <u>BH.01.MAY0323.R16 – Addressing Adverse Childhood Experiences (ACEs) in</u> <u>Wellington-Dufferin-Guelph</u>

Dr. Mercer introduced and J. Tomasik reviewed the contents of BOH Report BH.01.MAY0323.R16 – as follows:

- This report highlights the work of public health, in partnership with community partners such as Community Resilience Coalition of Guelph and Wellington, to raise awareness of ACEs. This report looks at the critical importance of early detection of ACEs and intervention to put children on the right path to overall health and wellness.
- In the WDG community, eighty (80) percent of adults have reported experiencing at least one ACE and thirty (30) percent have experienced four or more ACEs. The more ACEs someone experiences in their lifetime the more likely they are to have negative outcomes later in life.
- This project is funded by various grants, including an Ontario Trillium Foundation grant.
- WDGPH will continue to play a leading role in increasing awareness and knowledge of ACEs in WDG with a goal of preventing and reducing the effects of ACEs while building a safe environment for children and youth.
- A Board member advised that Family and Children's Services of Guelph and Wellington County is looking for adult mentors from the WDG community. More information can be found on their <u>website</u>.
