4.0 MOH Updates

MOH Update(s):

Dr. Mercer provided an update as follows:

• Health Analytics public local data portal aimed at supporting knowledge exchange with WDGPH's partner agencies.

- <u>Upcoming</u> respiratory season. There is a week over week increase in cases being seen in WDG as well as provincially. Although not a large increase the trend is upward.
- There will be a covid vaccine available this fall along with the annual influenza vaccine, and both will be delivered by public health, pharmacies, and primary care providers.
- Residents of WDG will be able to receive their flu and covid shots at the same time in the same place if desired. Both vaccines may be safely given at the same time or at any interval between doses.
- A board member requested clarification regarding the potential for future lockdowns. Dr. Mercer assured the board and public that a lockdown would only happen with overwhelming evidence of public risk and is not on the horizon.
- Thankfully within WDG there is a high rate of vaccination and additionally many people have had Covid resulting in a high rate of baseline immunity. Despite this it is important for everyone to receive an annual Covid and flu vaccine to protect themselves each season.

8.0 BOH Report(s)

BH.01.SEP0623.R22 – 2023 Poverty and Health Report

Dr. Mercer introduced and J. Martalog and E. Campbell reviewed the contents of BOH Report BH.01.SEP0623.R22 – as follows:

- The importance of this report was highlighted, and it is hoped that this will become an annual report.
- This report summarizeds the local picture of poverty. Poverty has detrimental effects on opportunities for education and employment and has a long history of stigmatization and systemic discrimination.

- There is a strong link between low income and health issues with higher rates of conditions such as diabetes, asthma, anxiety disorders and high blood pressure, present in lower income communities.
- Better healthcare services are more easily accessed by wealthier communities.
- Poverty rates have increased to higher levels than pre pandemic with the cessation of the pandemic income supports.
- WDGPH is using local poverty data to design more equitable programming.

BH.01.SEP0623.R23 - Secondary Impacts of the Pandemic on Children and Youth

- The lockdowns that occurred over the COVID-19 pandemic had a major impact on youth.
- This report speaks to the cascading impacts of the pandemic on child and youth wellbeing.
- Primary impacts are only part of the story, secondary impacts are the effects on individuals and their families. They are far-reaching, complex and have the potential to affect the community for years to come.
- Preliminary recommendations from WDGPH are reviewed, and a fall forum will be held in 2023 with community partners to work toward implementing these recommendations.

- Community pop-up clinics will also be available and Agency staff will continue to support immunization efforts in congregate settings and residents who are homebound or not mobile.
- In-office and homebound clinics will continue after the conclusion of the 6-week campaign.
- Vaccines will be made available throughout WDG at universities, public health offices, pharmacies, and through participating primary care offices.

- Further research will be conducted locally to study the impact of HPV vaccine series completion in WDG.

BH.01.SEP0623.R26 - Talking to Youth About Vaping

Dr. Mercer introduced and A. Vanderlaan reviewed the contents of BOH Report BH.01.SEP0623.R26 – as follows:

- This report details the many negative risks associated with vaping, including lung disease, asthma, and cancer.
- Around 15% of high school age children report vaping in the past year and it was most commonly linked with youth who identify as non-binary or LGBT.
- Dependency on vaping is increasing as are the numbers of youth that report being addicted to vaping, with 40% reporting trying to quit within the last year.

- WDGPH will continue to monitor these trends and support youth to make healthy choices.

- A Board of Health report in November will speak to inspections and enforcement measures related to selling illegal vape products. If you know of a retail store selling illegal vape products, report it to public health.
